NOTICE TO BIDDERS

Sealed bids will be received by the Dodge County Clerk, Dodge County Courthouse, 435 N Park, Room 102, Fremont NE 68025 until Wednesday, October 23, 2019, at 11:10am CST, for construction of three concrete box culverts, one bridge rehabilitation, and associated grading, located between Sections 2/3-T18N-R6E and Sections 1/2-T17N-R8E in Dodge County, Nebraska and between Section 5/8-T18N-R11E and Section 3/10-T18N-R9E in Washington County, Nebraska, and other work incidental thereto. The sealed bids are to be addressed to "ATTN: Dodge County Clerk, Dodge County Courthouse, 435 N Park, Room 102, Fremont NE 68025" and plainly marked "Dodge / Washington County – County Bridge Match Projects."

Proposals must be submitted on the forms furnished with the Bid Documents. **Please only submit Divisions 5 and 6.**

Each bidder will be required to submit with his proposal a Bid Bond or Certified Check made payable, without condition, to the County Treasurer of Dodge County, Nebraska, in an amount equal to five (5) percent of his proposal.

The bidder to whom the contract is awarded shall furnish within ten (10) days after the award a surety bond or bonds in a sum equal to the full amount of the contract. The form of the bonds and surety shall be acceptable to the Dodge County Board of Commissioners.

The bidder will include an estimated time of beginning and completion for the project with the proposal. The required completion date is November 1, 2020. The Contractor will be allowed 60 calendar days for completion of each site after beginning work.

The Board of County Commissioners reserves the right to reject any and all bids or to waive any irregularities in bids.

Awarding of the Contract will be in accordance with the eleven points enumerated under "Competitive Bidding; Consideration", COUNTY PURCHASING ACT, N.R.S. Sections 23-3101 through 23-3114 and any competitive bidding requirements of Nebraska Statutes 16-321, et. seq., and the Dodge County Board of Commissioners will, at their discretion, award based on the lowest or best bid.
