We have started construction on the new restroom facilities at the fairgrounds and have completed the installation of the new camper hook ups. This spring as we received final estimates and bids from our contractors and we found out that our plumbing cost was going to be \$7,000-\$12,000 higher than originally planned. This was mainly due to the increase in cost for this service from two years ago when we started planning as well as we needed to involve a professional engineer for our septic holding tank per NEDEQ.

All other funding came through as planned and we should be on track to have the restrooms and meeting room completed by mid-July.
