Upon consideration of the evidence and computation of inheritance tax liability as shown on the Inheritance Tax Worksheet filed herein, and incorporated herein by reference, THE COURT HEREBY ORDERS, DETERMINES AND ASSESSES Inheritance Tax herein as follows:

There is due and payable by reason of the death of Larry Harlan Wigren inheritance tax in the total amount of \$33,188.76 which shall be paid to the Dodge County Treasurer of Dodge County, Nebraska.


