

Honorable Members:

After reviewing a request from Tom, Marka and Mitch Sawyer, I am respectfully submitting my study of the vacation of an unnamed street, located in the L.J. Abbott's Subdivision located east of Highway 77 & 275 between Cathy and Judy Street at the east border of Block 1 and the west border of Block 2 located in the SE ¼ SW ¼ Section 2, Township 17 North, Range 8 East in Platte Township.

The unnamed street has a 66-foot wide Right-of-Way which is 33 feet south of the center of Cathy Street and then going south for 594.57 feet. The street was never constructed and in my opinion, serves no purpose to the traveling public.

I recommend to the Dodge County Board of Supervisors to vacate this unnamed Street in its entirety for an approximate distance of 594.57 feet in length.


I have attached a plat of survey of the L.J. Abbott's Subdivision showing the street.
